About 5 years ago, I left the church and became lukewarm. Meanwhile I developed acute arthritis on the left knee and had difficulty climbing a building without an elevator. Still less, the hearing on the left

ear worsened due to the aftereffects of brain tumor surgery and I was diagnosed with hearing impairment at the end of 2023. Then, I

began wearing a hearing aid.

In February 2024, I could hardly move the left arm due to the dislocation of left shoulder, and the pain caused great troubles in daily life.

At that time, I was in the middle of 300-day vowed prayer for the will of God and the choice of my future church. At the end of February, I was strongly urged to return to this church and on Sunday, March 10, I came back with emotion.

Honestly speaking, I was so afraid to mount the stairs to enter the chapel on the third floor. When I stepped onto the first stair, however, I had no pain at all and climbed up to the third

floor comfortably.

As I experienced God's healing work in my first service in this church, I became happily assured of God's answers and guidance.

Next day a Vowed Daniel Prayer Meeting started and I attended it with pounding heart. I repented of my disobedience to God's will and earnestly

asked for His grace, filled with the Holy Spirit.

Then, I started hearing in the left ear in which I had never heard before, and removed a hearing aid with faith. A Divine Healing Meeting was held on Friday, March 29 and when the speaker Pastor Soojin Lee prayed for the sick from the podium, my body felt like flying in the air and became refreshed. After that, I could lift up the left arm and move my whole body comfortably. And I could hear clearly in the left ear.

My dear Lord blessed me to meet and experience the living God and guided me to lead a happy life in this church. I give all

It happened in 2020. One day it looked like a thorn got stuck in the right middle toe and I looked into it closely. But nothing was found there. The pain got worse with the passing of time and later I couldn't bear whenever my toes touched anything.

I had a great difficulty walking and had to take a break in the middle due to unbearable pain. I had to step down carefully and gently with the foot blade lest the sole of my foot should touch the ground. It brought about twisted posture and back pain. Two years later, the same symptom occurred to the left middle toe, so I had to wear only Crocs women's free sail clog.

The hospital diagnosed me with 'interphalangeal neuroma' which refers to the feet's nerve compression syndrome and told me that it was due to unknown cause and would not be healed completely even with surgery. I took medicines but there was no improvement. I stopped going to hospital.

I was overwhelmed with anxiety and fear, thinking, 'Wouldn't I be able to walk? Should I rely on an electric wheelchair?'

An idea flashed through my mind that I could rely on God alone. I began praying eagerly and waited for God's answer. I tried my best to change by truths. For a year it seemed that His answer was still far away from me.

On January 8, 2024, while I was praying with an earnest desire at a Vowed Daniel Prayer Meeting, God's grace came upon me unexpectedly.

My past wrongdoings came up in my mind: I got upset and angry and

sometimes showed hot temper in the situations that I thought not fit and spoke negative words, etc. I repented of them with a realization that I had not changed even though I had listened to the holiness gospel for long.

"Menopausal syndrome and asthmatic cough disappeared!"

My menopausal symptoms were particularly severe and it caused many difficulties in daily life. It started on an autumn day in October 2023. My body was abruptly burned with fever and my clothes were drenched in sweat. It happened to me even in winter and I could not wear my clothes properly. Sometimes my body cooled down in the sweating, so I would have cold with runny nose and sore throat.

Whenever I coughed, I suffered from breathing disorder. I had great troubles even in talking on the phone at the office because I couldn't stop coughing. It worsened in closed spaces including subway, so sometimes I had to get off the subway in the middle due to severe coughing.

It got worse and worse in March of 2024 and I developed asthmatic cough. I took courage and was strongly determined to receive divine healing from God. I attended a 21-day Vowed Daniel Prayer Meeting from March 11 through 31 in preparation of the healing at a Divine Healing Meeting in March.

It was not easy for me to cry out in prayer due to coughing, but I thought, 'If I die, I will die' and prayed earnestly and fervently with an eager desire for the healing.

Jesus is the only person who is worthy to save mankind according to the law of the redemption of the land (Leviticus 25:23-25). Now let us delve into the detailed conditions.

First, the Redeemer must be a man as a close relative of Adam.

Leviticus 25:25 says, "If a fellow countryman of yours becomes so poor he has to sell part of his property, then his nearest kinsman is to come and buy back what his relative has sold." The law of the redemption of the land says that if a poor man sold some of his possessions his nearest kinsman could buy back what he had sold.

When Adam sinned, he came to belong to the devil and handed over all his authorities to the devil. The person who is worthy to redeem him and his authorities from the devil must be a close kinsman to Adam. It spiritually means the person must be composed of spirit, soul, and body like Adam just as written in 1 Corinthians 15:21-22, "For since by a man came death, by a man also came the resurrection of the dead. For as in Adam all die, so also in Christ all shall be made alive." As recorded in Revelation 5:1-5, Jesus is the only person who is worthy to save mankind according to the law of the land redemption.

John 1:1 says, "In the beginning was the Word, and the Word was with God, and the Word was God," and verse 14 says, "And the Word became flesh, and dwelt among us, and we beheld His glory, glory as of the only begotten from the Father, full of grace and truth." The Word became flesh and put on a human form and came to

this earth. He was Jesus. Jesus is the Son of God who has both divinity and humanity. He was born putting on a human form with bones and flesh.

The history is divided into two groups: BC and AD according to the birth of Jesus. This fact proves that Jesus came to this earth in the flesh.

Second, the Redeemer must not belong to Adam's descendants.

Suppose you are supposed to be sent to jail due to a great debt. If your wealthy brother pays off all your debts, you can be released from the punishment. If your brother is in debts, he is not capable of paying off your debts.

Similarly, only sinless and blameless person is worthy to redeem others from their sins. Since Adam disobeyed and sinned, all have been born a sinner so that no one is worthy to redeem others from sin.

When God created man and woman, He gave them each seed of life respectively; sperm for man and egg for woman. A life is conceived through the combination of a sperm and an egg. The seeds of life contain each parent's life energy by which a child resembles their parents in the face, body

structure, personality and habit. It also includes the parents' sinful nature.

Such sinful nature has bene inherited to children from their parents and forefathers since Adam sinned. This is called 'original sin.' This is how everyone inherits sinful nature from their parents at birth.

Romans 5:12 also says, "Therefore, just as through one man sin entered into the world, and death through sin, and so death spread to all men, because all sinned." As said, death came to the word because of one man Adam's sin and all are sinners and destined to death.

All are born with inherited sinful nature, 'original sin' because they are Adam's descendants. Therefore, none of them is worthy to become a redeemer for mankind. There is only one person in the world who is worthy to save mankind according to the law of redemption of the land. He is Jesus, God's only begotten Son. He met the conditions for the Redeemer for mankind because He was a man but did not belong to Adam's descendants. Why was Jesus a man but not a descendant of Adam?

Jesus was from the Tribe of Judah and the Son of David and was born between Joseph and Mary in genealogy. But He borrowed her womb and was conceived by the power of the Holy Spirit. So, He did not inherit any sinful nature and had no original sin (Matthew 1:20, 23).

Therefore, Jesus is far away from original sin because He is not a descendant of Adam. He is worthy to become the Savior for mankind.
